2. COMPOSITION/INFORMATION ON INGREDIENTS

CAMELLIA OLEIFERA SEED OIL 100%

This carrier vegetable oil is obtained by the expression of seeds. Chemically it is the glyceride esters of fatty acids (primarily Oleic Acid). The oil is non-hazardous.

3. HAZARD IDENTIFICATION

No known ingredient of this product is classified hazardous.

4. FIRST AID MEASURES

Skin Contact:	Remove contaminated clothing. Wash off with soap and water. If irritation occurs, get medical attention.
Eye Contact:	Immediately flush eyes with plenty of cool water for at least 15 minutes. Get medical attention if irritation occurs.
Inhalation:	Oil is non-volatile. If inhaled, removed to fresh air. Get medical attention if symptoms appear.

5. FIRE FIGHTING MEASURES

Suitable Extinguishers: Normal extinguishers can be used
(Carbon dioxide, dry powder, foam)

Unsuitable Extinguishers: Water jet, water spray

Exercise caution when fighting any chemical fire.
Use water spray or fog for cooling exposed containers.

6. ACCIDENTAL RELEASE MEASURES

Personal Precautions: Equip clean crew with proper protection.
Respiratory protection equipment may be necessary.

7. STORAGE AND HANDLING

Precautions for Safe Handling: No direct lighting. No smoking.
Ensure prompt removal from eyes, skin and clothing.

- Storage Conditions: Store at ambient temperature.
Store away from oxidizing substances e.g. bleach.
Keep container closed when not in use.
